- Our natural manufacturing process controls the degree of polymerization (DP) and the $\alpha(1-6)$ linkages to ensure consistent high levels of isomalto-oligosaccharide concentration from alternate starch sources.
- VitaFiber™ Basic (Syrup) is transparent clear or pale yellow colored high density syrup with 100% solubility.
- VitaFiber™ Basic (Syrup) has a relative sweetness equal to ~60% of sucrose.

- VitaFiber™ Basic (Syrup) is transparent clear or pale yellow colored high density syrup with 100% solubility.
- VitaFiber™ Basic (Syrup) has dried solid contents up to 75% with 99.5% carbohydrates, and having dietary fiber contents of $\geq 91\%$. The free glucose content is $\leq 5\%$.
